Information on Operation against Illegal VoIP Installation in Chittagong at Pachlaish Thana:





An operation against illegal VoIP establishment was conducted by a joint team of BTRC and RAB-7, at 8:30 PM to 1:00 am on 14th March 2017 in the spot – Flat 4/A, Sky blue tower, Taherabad R/A, Aterer Depo, Pachlaish Thana, Chittagong.

Equipment seized during this Operation:

Calls made via the internet protocol are sent to SIMboxes which redirect this illegal VoIP traffic onto Mobile Networks.

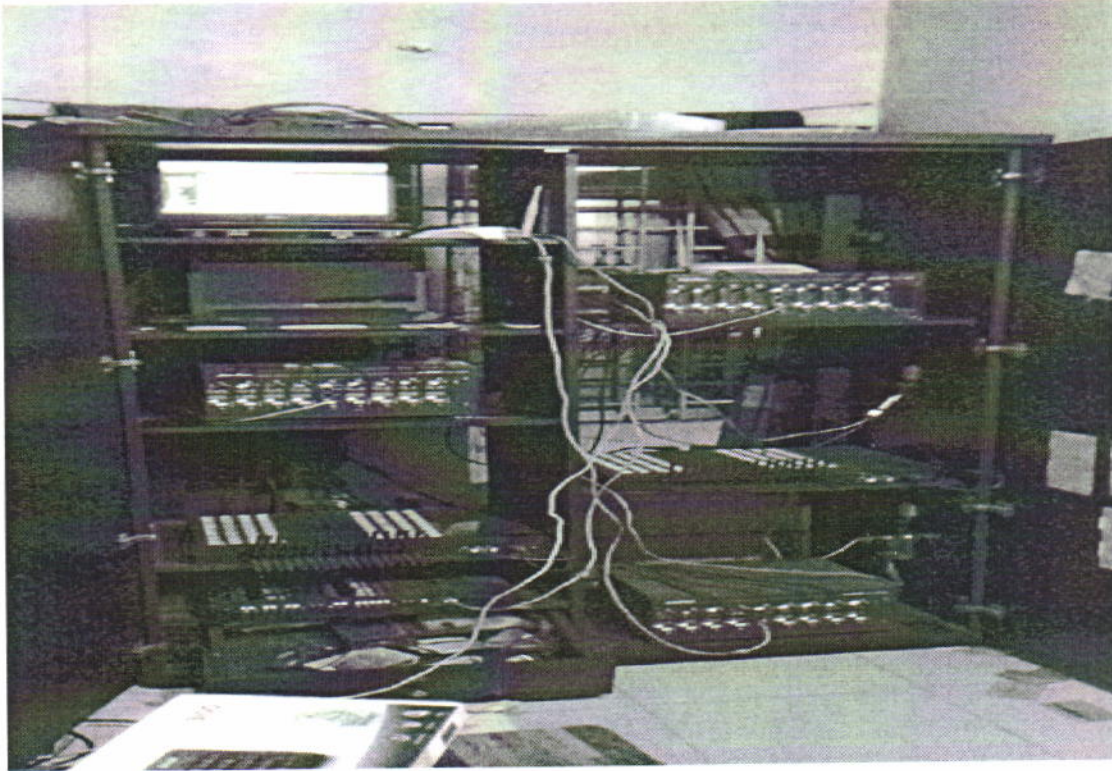
Calls were made with above SIM cards allegedly used in the SIMBOX of illegal VoIP Installation.

Three accused person has been arrested for illegal VoIP activities. Criminal lawsuits have been lodged for such illegal activities under the Bangladesh Telecommunication Regulation Act, 2001. The materials confiscated during this operation are now under the police custody of Pachlaish Thana, Chittagong.

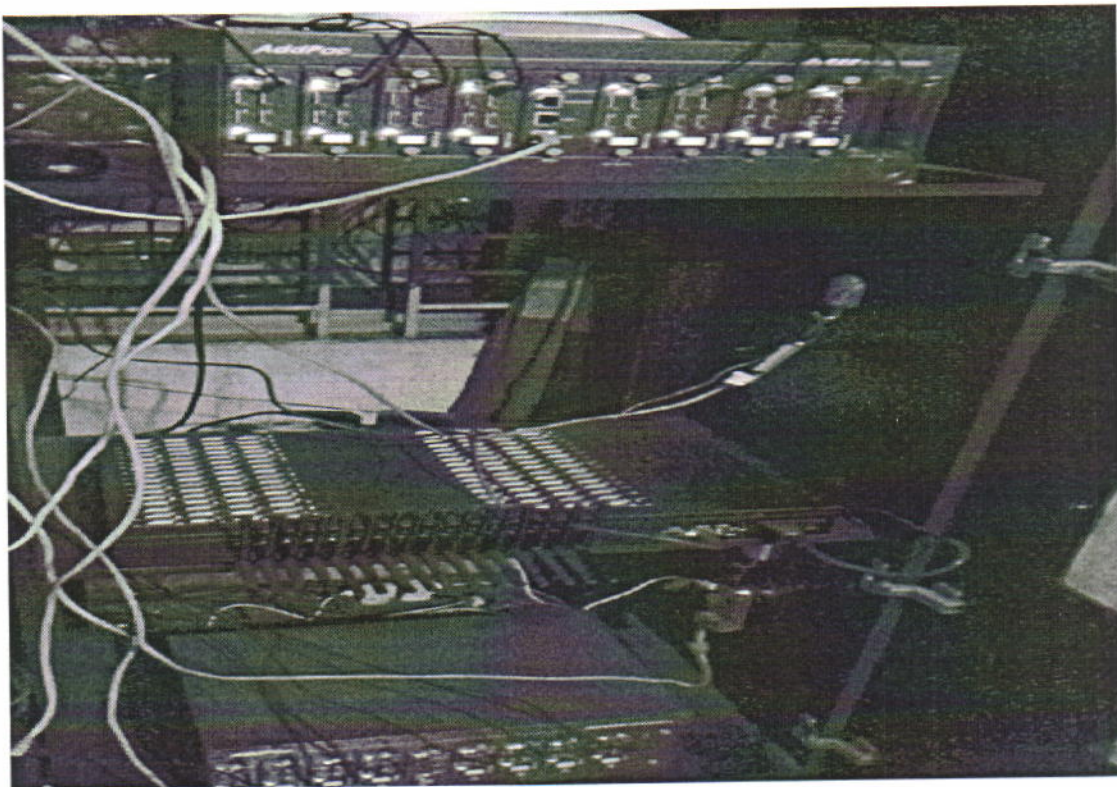

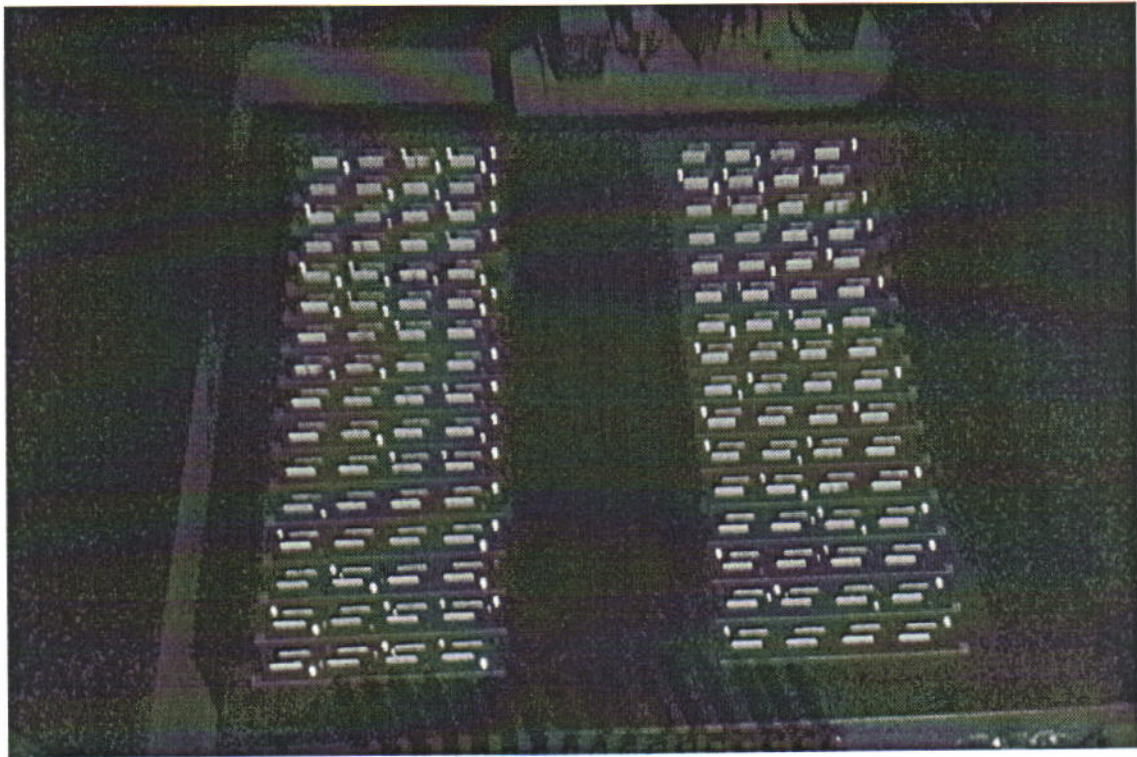
